

**MINUTES OF LLANDYFAELOG COMMUNITY COUNCIL MEETING  
HELD ON 6 FEBRUARY 2025 AT 7.30PM**

**1. Present:** Cllrs Nicola Jones (Chairman), Janet Knott, Philip Davies, Jenny Jones, Eifion Jones, Elfyn Williams, Rheinallt Jones, County Councillor Tyssul Evans and Arfon Davies (Clerk).

**Apologies:** Cllrs Meinir James, Carys Thomas and Viv Davies.

Congratulations were expressed to Cllr Carys Thomas on the birth of her daughter. It was noted that Cllr Thomas was therefore on maternity leave with apologies for Council meetings accepted as a result. The purchase of a £20 voucher gift was approved.

It was noted that Cllr Viv Davies had provided apologies for the meeting with his 6 month period approaching. It was agreed to accept the apologies for a further month with the Clerk to discuss the possibility of attending meetings remotely again with Cllr Davies.

The Chair noted the recent bereavements in the Community and expressed the Council's deepest condolences to the families. A moment of silence was held in their memory.

**2. Declarations of Interest**

**3. Public Participation**

It was noted that no Members of the public were in attendance on this occasion.

**4. Minutes of the meeting of Council held on the 9<sup>th</sup> January 2025 were confirmed and signed.**

**5. Matters Arising**

- 1. Planning application, PL/02147 in property in woodland area – Idole to Pentrepoeth** – The decision of the Planning Inspector was received which had been to quash the Enforcement Notice as it had not covered the full extent of the possible planning contraventions. An opportunity was therefore available to the County Council to submit a new enforcement notice. This was now to be considered. Noted.
- 2. Concerns relating to parking on double yellow lines in Llandyfaelog** – Council awaited further updates on the matter. Noted.
- 3. FP29/4 Pentrepoeth** – Confirmation was received that the final draft of the legal agreement was in place and would be provided to the landowners for approval in order to allow the replacement furniture to be installed. Noted.
- 4. Planning Enforcement Issues at fields in Idole** – Council awaited further updates on the matter. Noted.

5. **National Grid – Substation in Llandyfaelog Area** – Further investigatory work had been undertaken by the proposed developer during January, leading to disruption on the A484 highway in Upland Arms. Noted.
6. **Road safety issues at Bancycapel** – Confirmation was received that the Police were supportive of a no overtaking at this location with further consultation to be undertaken on the matter. Noted.
7. **Council Chairman’s Chain** – The Clerk continued to seek prices for new name badges for the Chain.
8. **Tree cutting in Croesyceiliog - FP 29 4/1 and 4/2** – Confirmation was received that the County Council had written to the landowner in relation to the fallen tree with a response awaited. Noted.
9. **Waiting restrictions proposals for Ysgol Gyfun Gymraeg Bro Myrddin** – Confirmation was received that the Cabinet Member meeting had taken place with the Council’s objections noted and the order progressed. A request had been made for responses to the Community Council’s queries on the matter with further information awaited.
10. **PL/04973 - 1-4 Gelligaeros Trading Estate, Cwmffrwd, Carmarthen, SA32 8DJ** – Council awaited further updates on the matter. Noted.
11. **Daffodil and Tree Planting Project** – Tree planting had been completed at Idole Field. It was noted that the daffodils were growing well around the Community. Noted.
12. **Maesglasnant, Cwmffrwd** – It was noted that the matter had gone before Court in January with a stay in place until June. Noted.
13. **Concerns regarding traffic speeds from Pibwrlwyd at Bolahaul Road Junction** – The Council had been advised to raise the matter with the GoSafe Team. The Clerk had made contact on the matter and awaited a response.
14. **Footway lighting at Llandyfaelog** – The County Council had confirmed repairs requests. The matter will be chased as completion was awaited.
15. **Stray dogs at Idole** – The matter continued to be monitored. An incident was noted the previous day with a dog crossing the road in Idole causing vehicles to break.
16. **Water pooling between the A484 junction (Idole) and Croesyceiliog** – It was reported that works had been carried out that were hoped to alleviate the issues. Noted.
17. **50mph sign on the A484 at Cherry Trees** – The matter will be chased for an update.
18. **30mph road markings at Llandyfaelog** - Council awaited further updates on the matter. Noted.
19. **Flooding issues at Heol y Lan** – Works were noted to have been carried out by the local landowner, residents and the County Council. Noted.
20. **Blocked gutter at Cilfeithy Uchaf** – The gutter had been investigated with a collapsed pipe identified. Noted.

It was agreed to retain the services by Michael Leefe due to the quality of the works provided.

## **8. Community Handyperson**

The Clerk confirmed 28 hours worked in January with a total cost of £616.00 approved. Additional costs of £114.24 for works detailed in item 7 above were approved.

The Clerk presented draft documents for the Handyperson tender. These were approved and will be advertised for prices to be considered in the March meeting.

## 13. Any Other Business

1. It was noted that food waste was again being left along Heol y Lan and adjacent areas.
2. The Clerk had raised water pooling with the County Council at Cilgadan again, with the suggestion raised on creating an opening in the pavement to enable water to escape. Following a further inspection, the County Council had carried out the works.
3. The Clerk had reported a Christmas tree flytipped near Gwynfryn.
4. The Clerk had reported the need to clear the road at Fforest Uchaf of muddy deposits.
5. A possible Community First Aid Training Event will be requested.
6. A quiz in aid of Llandyfaelog Church was noted for the 7<sup>th</sup> March 2025.
7. It was noted that 3 pylons were being replaced between Llechwdni and Gletwyn.
8. The condition of the road at Pwll y Baw was raised as a concern, with work not being carried out by the County Council possibly causing an impact to funeral arrangements. Cllr Tyssul Evans agreed to make enquiries on the matter.
