## **Meeting regarding plans for Llandyfaelog Sub Station and related issues**

**Thursday 7<sup>th</sup> November 2024 6.00pm**

**Present:** Cllr Nicola Jones (Community Council Chair), Cllr Meinir James, Cllr Tyssul Evans, Cefin Campbell AS, Adam Price AS and Arfon Davies, Clerk.

**Apologies:** None

The Chair welcomed Adam Price AS and Cefin Campbell AS to the meeting and thanked them for their attendance. The meeting had been arranged in order to discuss matters relating to the proposed Llandyfaelog Sub Station and power lines and to brief the AS' on matters of concern relating to this in the Community.

The Chair shared maps of the proposed development for information.

Issues discussed included:

- Pylons, undergrounding;
- Substation size and location and future developments;
- Consultation process;
- Whether other locations had been considered as part of the process;
- Noise levels / screening;
- Traffic issues during development works;
- Mitigations that could be put in place;
- Community benefit;
- Possible impact on property values;
- Loss of trees and hedgerows;
- Flooding issues.

The AS' noted a need to understand the Community's wish in relation to the project:

- To oppose?
- To work with the developers to mitigate the impacts and provide for the maximum community benefit?

Areas of possible discussion with the developers were noted as:

- Reduction of the scale of the proposed development;
- Undergrounding in preference to pylons;
- Provision of full visual plans on the impact of the substation and pylons for the Community.

It was agreed to update the AS' on dates for consultation along with information on Community views as the full proposals became available. A site visit will be arranged when convenient to the AS'.
